- What data we hold, such as your name, email address, your phone number, as well as any other information you provide via the contact methods above;
- Why and how we process your data; and,
- How we seek, record, and manage your consent for us to control your data, including your opt-• in for consent;

And, after consent when you have supplied data to SPCR, your rights to:

- Access your data;
- Rectify the data to ensure the quality of data that we hold;
- Control retention and disposal of your data;
- Restrict processing of your data;
- Enable your data to be transferred to another controller data portability; and,

- Once it is no longer needed, we will dispose of your data in a safe and secure manner, in • accordance with SPCR's retention policy,
- We only provide your data to select third party clients solely for the purpose of carrying-out a trial, and this would be on a need-to-know basis. We do not use profiling, and we do not sell or in any other way disseminate your data to third parties, other than as specified for study purposes.
- We constantly review our Privacy Policy to improve it and enhance the protection of your data.

Our website aggregates information on how your data is used but does not collect any personally identifiable data during this process.
